OLENTANGY GROWS TO FOURTH LARGEST IN STATE



This past fall, Olentangy Schools welcomed 22,573 students into our schools to kick off the 2021-2022 school year. From brand new kindergartners entering the classroom for the first time, to high school seniors beginning their last year, the continual growth in student enrollment has propelled Olentangy Schools to the fourth largest K-12 school district in Ohio.

"A primary benefit of Olentangy Schools becoming the fourth largest district in the state, is the representation Olentangy will have on the Ohio School Board Association. With board member Mrs. Mindy Patrick as Olentangy's representative, we will have a stronger influence on the direction the OSBA takes on academic and legislative education issues," shared Superintendent Mark T. Raiff.

The District's facilities committee relies on enrollment projections in forecasting student population growth and planning the buildings necessary for educating all of Olentangy's students. The District's sixth middle school, located in Delaware County south of Berlin High School along Piatt Road, is funded through the spring 2020 bond issue. Jeff Gordon, Director of Business Management and Facilities, reports that construction is currently progressing on schedule.

OLENTANGY SCHOOLS GETS PANDEMIC RELIEF FUNDS

When Governor DeWine signed HB 169 into law in December, \$20 million in federal funding was earmarked for Olentangy Schools. Funding from the American Rescue Plan Act equates to approximately 4.16 mills in operational funding. Olentangy Schools is developing a spending plan for these funds in accordance with applicable guidelines. More information will be shared at future Board of Education meetings.

Olentangy Schools Board of Education welcomes in Dr. Kevin Daberkow and Mr. Brandon Lester



Dr. Kevin Daberkow

Dr. Daberkow grew up west of Cleveland and settled in Central Ohio. He has been teaching as an elementary school teacher since 2001, teaching on the Southside of Columbus. Shortly after beginning his teaching career, Dr. Daberkow began his doctoral work in school finance and economics and completed his Ph.D. at Ohio University. He is passionate about school funding in Ohio. "I am blessed with a great family that includes my wife (who is also an educator), two younger children that

attend Olentangy Schools and my oldest daughter that graduated from Otterbein in the spring of 2021," said Dr. Daberkow.

In addition to teaching math to 5th graders in Columbus City Schools, he also teaches in higher education at Ohio University, Ashland University and is a doctoral advisor and dissertation committee member at Franklin University. The Daberkow family is actively involved with Worthington Christian Church and spends most of their free time supporting their children's sports activities. He is thrilled to raise his family in Delaware County as his children thrive attending Olentangy Local School District.

"The reason I ran for Board of Education is that I know the excellence we enjoy in our school district is not by accident. Mr. Brandon Lester

Mr. Lester is an attorney who currently serves as Senior Associate General Counsel at The Ohio State University, specializing in faculty and academic issues, as well as complex matters involving constitutional law, policy, litigation, crisis management, Title IX, compliance, dispute resolution and more. Previously, he practiced labor and employment law and litigation in private practice, represented state entities on major appeals in the Appeals Section of the Ohio Attorney

General's Office and served as a law clerk for the late Chief Justice Thomas Moyer of the Supreme Court of Ohio. He provides pro bono legal services, serves as a mentor, coaches youth soccer, and speaks to classes about legal and writing issues. He and his wife Jennifer are the proud parents of two Olentangy students.

"When we moved to the district a little over five years ago, we immediately felt welcomed into the Olentangy community," said Mr. Lester. "As someone who has always been passionate about both public education and public service, I was excited about this opportunity to give back to such a wonderful district. While the last few years have been challenging for schools across the nation, I see these challenges as opportunities to come together and build up our community," Mr. Lester explained.

His top priorities include supporting the mental health of students, teachers and staff. "We have to continue to find ways to build a culture of support without stigma," Mr. Lester remarked. "I am looking forward to engaging the community in building our future. We have to ensure that our schools are supportive environments for all so that every student is empowered to do their best, and that all depends on building a culture of communication and respects," said Mr. Lester.

"The Robertson Construction team is completing the building envelope (walls and roofing), which will enclose the building and allow crews to continue to work through the winter," shared Mr. Gordon. "We are very fortunate that our construction partners prepared for long material lead times and are not facing supply chain delays," said Mr. Gordon.

The sixth middle school will add 46 classrooms and space for up to 1,000 students in grades 6-8. It is projected to open for the 2023-2024 school year, in time to prevent a deficit in middle school classroom space across the District. The timeline for opening the 17th elementary school also funded in the spring 2020 bond issue, has been extended to the 2025-2026 school year.

In their annual report to the Board of Education on October 2021, the Facilities Committee projected a need for the 18th and 19th elementary schools in 2027 and 2030, respectively. Enrollment projections do not reflect a demand for another Olentangy middle school or high school in the next 10 years.

TRADEMARK LICENSING PROGRAM ROLLOUT

In partnership with the implementation of the new trademarked school brand identities, Olentangy Schools has established a licensing program for the use of both district and school logos.

First steps of the licensing program took place in December 2020, when the Board of Education approved a contract with K12 Licensing. The District will now profit from the sales of Olentangy trademarked products while K12 Licensing will protect and promote the use of Olentangy branded items.

The second step in the licensing process has been partnering with local vendors to create products with Olentangy's brand identities or partnering with a school, group or team as well as third-party vendors.

"The vendor license agreement is essential in ensuring that all gear, signage and other promotional items follow our brand identity guidelines," shared Chief Communications Officer Mrs. Krista Davis. "The process has already improved our communication with vendor partners and will strengthen those relationships in the community."

The final step in using the trademarked brand identities is the completion of a brand project request form, which approves all uses of the district and school names, logos, initials, mascot and buildings. "Volunteers, staff members and vendors submit a request form for approval, as a checks and balances for the proper use of all trademarked materials," stated Mrs. Davis.

The licensing program is a part of the District's strategic plan to establish a brand identity, while also creating a modest revenue stream for the District, creating consistent visual representation of our schools and fostering pride across the community. The use of an Olentangy Schools name, logo, initials, and/or building for advertising and promoting products or services is not permitted unless the District has authorized its use. In addition, the use of a logo may not imply that Olentangy Schools endorses or is part of a product, service or company.

- Opened and staffed a brand new elementary school, Shale Meadows, and welcomed 598 students.
- Several of our schools achieved national and state recognition through US News & World Report's annual Best Schools Report, with three of our high schools ranking in the top 30 in the state compared to over 600 high schools (Berlin High School is not yet eligible for this ranking).
- Twenty-five high school seniors were recognized as National Merit Semifinalists, and 35 additional seniors received Letters of Commendation.
- Met 18 out of 21 indicators on the state report card. These indicators measure proficiency percentages for how our students performed on the Ohio state tests last spring.

"During the past two years, students have learned the challenges and beauty of resilience in demonstrating patience and grace; we cherish our performances more than ever and are purposeful with these opportunities; we have been curious in hearing opinions that both align and differ with our own views; and students are approaching one another to ask for help, give words of encouragement and demonstrate kindness more than ever," shared Mrs. Silcott. OLENTANGY EARNS HIGHEST RECOGNITION IN GOVERNMENTAL FINANCIAL REPORTING



Olentangy Schools once again has been named a recipient of the Certificate of Achievement for Excellence in Financial Reporting by the Government Finance Officers Association of the United States and Canada (GFOA). The award, considered the highest form of recognition in the area of governmental accounting and financial reporting, is for the District's Comprehensive Annual Financial Report for the fiscal year which ended June 30, 2020. "The Comprehensive Annual Financial Report has been judged by an impartial panel to meet the high standards of the program, which includes demonstrating a constructive 'spirit of full disclosure' to clearly communicate its financial story and motivate potential users and user groups to read the report," the GFOA wrote in a release announcing the award. This is the 20th consecutive year Olentangy Schools has received the coveted award.

The GFOA established the Certificate of Achievement for Excellence in Financial Reporting Program (Certificate Program) in 1945 to encourage and assist state and local governments to go beyond the minimum requirements of generally accepted accounting principles to prepare comprehensive annual financial reports that evidence the spirit of transparency and full disclosure and to recognize individual governments that succeed in achieving that goal. The attainment of this award represents a significant accomplishment by a government and its management.
