WHEREAS, a dispute arose regarding payment due to Claimant pursuant to her employment contract following her departure from the District; and

WHEREAS, the Parties have negotiated in good faith, and it is now their intention to effect a full, final, and complete settlement of all disputes between them which were or could have been asserted up to the time and date the last of the Parties sign this Agreement.

NOW, THEREFORE, in consideration of the promises and covenants herein, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Parties agree:

#### 1. PAYMENT

The total amount of \$17,620.90 (seventeen thousand, six hundred and twenty dollars and ninety cents) will be paid to Claimant by or on behalf of the Board. The payment shall be made within thirty days following expiration of the revocation period described in paragraph 2 below. Claimant acknowledges and agrees she is solely and fully responsible for any taxes that may apply to this payment and shall indemnify and hold the Released Parties harmless as to any liability for these taxes.

Claimant acknowledges and agrees she is not entitled to any other payment or compensation from the Board and the Board's total monetary liability to Claimant shall not exceed the amount in this Section 1. Claimant acknowledges and agrees consistent with R.C. 3309.01(V)(2), the foregoing amount is for the cashing out of vacation leave and is not considered compensation for purposes of SERS contributions, and she agrees to indemnify the Released Parties for any finding for recovery incurred as a result of its payment.

#### 2. CLAIMANT'S RELEASE

In consideration for the payment and covenants in this Agreement, Claimant, on behalf of herself and all of her heirs, executors, administrators, beneficiaries, attorneys, representatives, agents, and assigns, hereby completely waives, releases, indemnifies, acquits, covenants not to sue and forever discharges the Board and all of its past, present, and future employees, members, insurers, underwriters, investigators, attorneys, agents, and representatives, and all of their heirs, executors, and administrators, and all other

persons, firms, or corporations with whom they have been, are now, or may hereafter be affiliated, in whole or in part (collectively from the Board to this parenthetical referred to as the Released Parties) from all manner of action, claims, demands, obligations, causes of action, rights, damages, losses, liens, charges, fees, debts, obligations, costs, interest, expenses, claims for attorney fees/costs/expenses, and compensation of any nature whatsoever, whether based on a tort, contract, or other theory of recovery, which Claimant may have to date or may hereafter have or acquire, for any reason whatsoever, which have resulted or may result from any alleged acts or omissions of the Released Parties from the beginning of time through the date the last of the Parties executes this Agreement. This includes without limitation any claims based on race, color, religion, age, sex, marital status, national origin, disability, ancestry, wrongful discharge, retaliation and/or any other theory of recovery or claim, whether legal or equitable, related to her employment or her separation from employment, including claims under Ohio law based on tort, contract, public policy or other theory, Title VII of the Civil Rights Act of 1964, the Americans with Disabilities Act (ADA), the Fair Labor and Standards Act (FLSA), Employee Retirement Income Security Act (ERISA), and the Family Medical Leave Act (FMLA), all as amended.

This general release of all claims shall also apply to any right or claim arising under the federal Age Discrimination in Employment Act of 1967, as amended (ADEA), the Older Worker Benefit Protection Act (OWBPA), Ohio age discrimination laws, or any similar municipal ordinance. While this Agreement does not affect any right that may not by law be released. Claimant does release and waive her right to file a court action or otherwise seek or accept individual remedies or damages. Claimant's release of these rights shall apply with full force and effect to any proceeding arising or relating to any such age discrimination charge. Claimant acknowledges she has been advised by this writing, as required by law: (a) the ADEA Waiver does not apply to any rights or claims that arise after the date Claimant signs this Agreement; (b) Claimant should consult with an attorney prior to signing this Agreement; (c) Claimant has 21 days to consider this Agreement (although Claimant may choose to voluntarily sign it sooner); (d) Claimant has seven days following signature to revoke the ADEA Waiver; (e) the consideration described above is in addition to anything of value to which Claimant is entitled for purposes of acting as sufficient consideration for her waiver of any age discrimination claim; and (f) the ADEA Waiver will not be effective until the date upon which the revocation period has expired. Nevertheless, the general release of claims except for the ADEA Waiver is effective immediately and not revocable. Claimant may, within seven calendar days after the signing of this Agreement, revoke the ADEA Waiver by written notice to the Board of Education actually delivered on or by the seventh day by 5:00 p.m. EST to Patrick J. Schmitz, 250 East Broad Street, 9th Floor, Columbus, Ohio 43215, email: pat@scottscrivenlaw.com...

Nothing in this Agreement shall be construed as an admission of liability by the Released Parties. The Released Parties deny any liability and state they are resolving this matter in order to avoid the expense, acrimony, and inconvenience of litigation. Claimant agrees she is not a "prevailing party" as defined by Section 504 of the Rehabilitation Act and related federal law and this Agreement is not an admission by the Released Parties of liability; violation of any federal, state, or local law, regulation, or obligation; breach of contract; commission of tort; or other civil wrong.

Claimant voluntarily and knowingly attaches her signature at the end of this document and indicates her absolute and unqualified intent and purpose to conclude all matters of dispute against the Released Parties so the Released Parties may use this paper in court to show Claimant is not entitled to receive any further relief from the Released Parties, on any theory of recovery, whether such action be instituted by Claimant or by anyone acting on her or their own behalf or under claim of right to so act, including any heirs at law or persons or corporations claiming any interest here and anyone who would be legally entitled to claim damages as a result, or as a consequence of the damages allegedly sustained by Claimant.

#### 3. BOARD'S RELEASE

In consideration for covenants set forth in this Agreement, to the extent allowed by public policy and law, the Board waives, releases, and forever discharges Claimant from all claims it may have against her, excepting only any findings for recovery made by the State Auditor in connection with an audit pursuant to Chapter 117, which Claimant shall have the right to challenge.

#### 4. FORBEARANCE OF CLAIMS

Claimant waives the right to file any charge or complaint in any forum for any reason against the Released Parties and agrees not to participate in any charge or complaint made against the Released Parties in any forum by any other person or organization, except when such waiver is prohibited by law. If any such charge or complaint is filed, Claimant agrees she will not accept any relief or recovery from it. Except as prohibited by law, in the event any such claim is filed, it shall be dismissed with prejudice upon presentation of this Agreement. Claimant further represents and warrants she does not have any claims, complaints, or charges currently pending against the Released Parties with any federal, state, or local agency or court.

#### 5. NON-DISPARAGEMENT

Claimant, the Board of Education's current members (Dr. Kevin Daberkow, Brandon Lester, Kevin O'Brien, Dr. Libby Wallick, and Dr. Lakesha Wyse), Superintendent Mark T. Raiff and Treasurer Timothy (Ryan) Jenkins agree they will not, at any time after the last of the Parties has executed this Agreement, disparage, defame, impugn, damage or assail the reputation, or cause or tend to cause the recipient of a communication to question the quality, integrity, competence, good character, or professionalism of any of the other aforementioned persons, except as required by law, court rule, or court order or as necessary to their attorney(s). This paragraph 5 binds, and shall inure to the benefit of, the Board members and the Board's Superintendent and Treasurer for the duration of their service on or employment with the Board.

The parties understand a breach of this provision would cause the other immediate and irreparable harm. Accordingly, they shall be entitled to seek injunctive relief restraining

the other from performing the act(s) which would constitute a breach of this provision and to enforce the provisions herein. In the event of a breach of this provision, the non-breaching party shall be entitled to liquidated damages in an amount equal to 50% of the total payments described in paragraph 1 of this Agreement. Nothing herein shall be construed to limit the parties from pursuing any other additional relief or remedy arising out of a breach of this provision of the Agreement.

#### 6. COOPERATION; WITHDRAWAL OF RECORDS REQUESTS

At the Board's request, Claimant agrees to cooperate and be available to the Board to respond to questions that arise out of Claimant's former responsibilities with the Board and to assist in the defense of and serve as a witness in any lawsuit or administrative proceeding faced by the Board considering matters in which Claimant was involved or had knowledge of while employed by the Board. If Claimant seeks employment with the Board at any point in the future, the Board may refuse or deny the application without consequence, and Claimant waives any and all claims that she may have based on the Board's refusal or denial.

Claimant's signature on this Agreement constitutes her withdrawal of any pending records requests.

#### CONSTRUCTION OF THIS DOCUMENT

This Agreement is the product of negotiations between the Parties and shall not be construed in favor of or against any party by virtue of any party's role in the drafting of any document or provision. It is agreed if this Agreement is construed by any court, it shall be construed and interpreted in accordance with the laws of the State of Ohio. The Parties agree the Delaware County Court of Common Pleas will have jurisdiction over any litigated disputes regarding this Agreement.

#### 8. WAIVER OF INTEREST

As a further inducement to the Released Parties, Claimant waives all claims to interest on all settlement amount proceeds, including, but not limited to, all interest on settlement amounts contemplated by R.C. 1343.03 and/or the holding in *Hartmann v. Duffey*, 95 Ohio St.3d 458 (2002) or its progeny. By executing this Agreement, Claimant expressly acknowledges and agrees the funds to be paid hereunder do not begin to become due and payable until such time as this Agreement is fully executed by Claimant.

#### 9. ASSIGNMENT OF CLAIM

Claimant warrants and affirms: (a) no part of the claims she has compromised here have been assigned to any other person, firm, company, corporation, or entity; (b) she is not presently the subject of any pending or contemplated bankruptcy proceeding; (c) she is not subject to any child support liens; and (d) she did not suffer any workplace injuries while employed by the Board.

#### 10. SEVERABILITY

In the event that any provision here becomes or is declared by a court of competent jurisdiction to be illegal, unenforceable, or void, this Agreement shall continue in full force and effect without it.

#### 11. ENTIRE AGREEMENT; NO ORAL MODIFICATION

This Agreement represents the entire agreement and understanding between the Parties concerning the subject matter here, and supersedes and replaces any and all prior agreements and understandings concerning such subject matter. There are no undertakings, understandings, promises, or conditions of any kind not set forth in the Agreement. Claimant acknowledges she has not relied upon representations or statements made by the Released Parties not specifically set forth in this Agreement. This Agreement may only be amended in a writing signed by all Parties.

#### 12. ACKNOWLEDGMENT; BOARD APPROVAL

The Parties acknowledge they are entering into this settlement and signing this Agreement of their own free will and had full and adequate opportunity to review its terms with an attorney and otherwise consult with an attorney. The Parties acknowledge they are fully aware of the legal and binding effect of this Agreement. The Parties further acknowledge that they fully and completely understand all terms of this Agreement.

This Agreement is conlingent upon formal approval by the Board.



The Fiscal Year begins July 1 and ends June 30. Fiscal Year to Date (FYTD) represents cumulative amounts through the month reported.

Closing out the month of December, we are trending to receive \$1.0 million more in revenue than originally budgeted for. This is due mainly to a slightly higher amount from the state than anticipated.


For expenditures, while our capital outlay is trending higher than expected, we will also receive reimbursements through the year to reduce this amount. Additionally, while pretty close to target, our actual expenditures are trending slightly lower than expected for an overall impact of actual expenditures are projected to be under budget as well.

With higher revenues and lower expenditures, we are projecting, at this point, to have a cash position that is \$2.4 million better than budgeted with the November forecast.

The District will continue to monitor actual revenues and expenditures through the winter, and while planning for FY2024, will make any needed updates in the Spring 2023 five year forecast.



7. Approval of Memorandum of Understanding with the Ohio Association of Public School Employees, AFSCME Local 4, AFL-CIO, Local #222

#### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered into by the Olentangy Local School District Board of Education (Board) and OAPSE Local #222 (Union), collectively the Parties.

WHEREAS the Board and the Union currently are subject to a Collective Bargaining Agreement for a term through June 30, 2025 (CBA).

WHEREAS the Board wishes to provide certain Intervention Aides with additional compensation on a one-time, non-precedent setting basis.

NOW THEREFORE, the Board and the Union agree to the following terms:

- Intervention Aides employed as of July 1, 2022 who fail the attendance criteria for a
  retention stipend in June 2023 pursuant to the first paragraph of Section 29.01, and
  who did not receive a \$250.00 one-time stipend in the first payroll in September 2022
  ("the Stipend"), will receive the Stipend in the 25th payroll in December of 2022.
  However, under no circumstances shall any Union member receive more than one
  stipend pursuant to Section 29.01 of the CBA and/or this MOU during the 2022-2023
  contract year.
- 2. The parties agree the second paragraph in Section 29.01 shall be removed from the successor CBA, including any extension or rollover of the current CBA. The Union further agrees it shall not propose any other amendments or modifications to Section 29.01 during negotiations or impasse procedures for a successor CBA.
- 3. This Agreement is based on specific circumstances. It sets no precedent and establishes no past practice.
- 4. The Union agrees to waive any right to file a grievance or an unfair labor practice charge with the State Employment Relations Board complaining of the facts and events that gave rise to this Agreement or the action to be taken pursuant to it except to enforce the above provisions and terms.
- 5. The Parties represent they have completely read all the terms of this Agreement, fully understand them, and have authority to enter this Agreement by their duly authorized representatives, and have caused this Agreement to be executed.

In accordance with the Agreement for Professional Services between the Olentangy Local School District ("Owner" or "OLSD") and CT Consultants, Inc. ("Engineer" or "CT"), the Owner and Engineer hereby agree to the following Task Order:

#### **Project Understanding**

The Olentangy Local School District needs to construct off-site improvements for Elementary School No. 17. These improvements consist of widening of Piatt Road, a waterline extension from the site to approximately the northeast intersection of Piatt Road/Peachblow Road and a sanitary sewer extension from the site to approximately the intersection of Cedar Crest Street / McNamara Place. A more detailed description on the off-site improvements are provided below:

<u>Piatt Road Widening</u>: Piatt Road is to be widened to provide a left turn lane into the new elementary school that is to be constructed on the southwest quadrant of the intersection of Piatt Road and Peachblow Road. This widening will occur along the east side of Piatt Road and begin approximately 250' north of Cedar Crest Street (matching the current three lane section of pavement) and continue north to the northern entrance of the elementary school, where Piatt road will then taper back to the two-lane section south of Peachblow Road.

<u>Off-Site Water Main Extension</u>: A proposed 8-inch waterline will be extended from the site along Peachblow Road to an existing waterline owned by Del-Co Water Co., Inc. near the intersection of Piatt Road/Peachblow Road. This waterline is intended to provide the required water supply for domestic and fire flow for the new school building.

Off-Site Sanitary Sewer Extension: A proposed 8-inch sanitary sewer will be extended from the site along Piatt Road to an existing 8-inch sanitary sewer owned by the Delaware County Regional Sewer District at the intersection of Cedar Crest Street / McNamara Place. This sanitary sewer is intended to provide the required gravity sanitary sewer service for the new school building.

#### **Scope of Services**

The services to be performed are as follows:

- Design Services
- Contract Administration Services (limited)
- Construction Observation Services (limited)

#### **Task 1 - Piatt Road Widening**

CT will perform the design and prepare the construction documents for the pavement widening of Piatt Road. CT will coordinate these improvements with OLSD and with the Delaware County Engineer's Office. The design effort will include preparing construction documents for the following:

- 1) Roadway widening as described in the project understanding above.
- 2) Revise the existing open drainage system (as needed) to account for the roadway improvements.
- 3) Develop maintenance of traffic plans/details.
- 4) Remove and replace signing and pavement markings due to the roadway improvements.
- 5) Utility coordination during design.
- 6) Prepare construction contract plans depicting the roadway improvements.
- 7) Prepare a final Opinion of Probable Construction Cost.

#### <u>Task 2 - Off-Site Waterline Extension</u>

The design services for these improvements will include the following:

- 1) Preliminary Alignment Plan
  - a) CT will prepare a preliminary alignment based on discussions with Del-Co Water. Once the alignment has been confirmed by Del-Co Water and OLSD, CT will prepare a preliminary opinion of probable construction cost for the project and then proceed with detailed design.
- 2) Final Construction Documents
  - a) CT will prepare detailed plans of the proposed work, technical specifications, details and other graphical representations of the work and incorporate them into the bidding documents to provide the contractor with an understanding of the scope of work to be performed. Utility coordination during design, maintenance of traffic and pavement restoration plans will be included if required.
  - b) Design deliverables will be submitted to OLSD for review and comment at 75% complete and 100% (Final) complete. CT will conduct review meetings with Del-Co Water and OLSD after each submittal.
  - c) CT will prepare a final Opinion of Probable Construction Cost when plans are approved by Del-Co Water and OLSD.

#### 3) Permitting

- a) CT will prepare and submit, the required plans, specifications, forms and application for a permit to install (PTI), with the Ohio Environmental Protection Agency (OEPA) for approval.
  - i) OLSD will provide all required permit fees.

#### Task 3 - Off-Site Sanitary Sewer Extension

The design services for these improvements will include the following:

#### 1) Preliminary Alignment Plan

a) CT will prepare a preliminary alignment based on discussions with Delaware County Regional Sewer District (DCRSD). Once the alignment has been confirmed by DCRSD and OLSD, CT will prepare a preliminary opinion of probable construction cost for the project and then proceed with detailed design.

#### 2) Final Construction Documents

- a) CT will prepare detailed plans of the proposed work, technical specifications, details and other graphical representations of the work and incorporate them into the bidding documents to provide the contractor with an understanding of the scope of work to be performed. Utility coordination during design, maintenance of traffic and pavement restoration plans will be included if required.
- b) Design deliverables will be submitted to OLSD for review and comment at 75% complete and 100% (Final) complete. CT will conduct review meetings with DCRSD and OLSD after each submittal.
- c) CT will prepare a final Opinion of Probable Construction Cost when plans are approved by Del-Co Water and OLSD.

#### 3) Permitting

- a) CT will prepare and submit, the required plans, specifications, forms and application for a permit to install (PTI), with the Ohio Environmental Protection Agency (OEPA) for approval.
  - i) OLSD will provide all required permit fees.

#### <u>Task 4 - Construction Administration Services</u>

The construction administration services for these improvements will include the following. <u>We have included an estimate of time for each task</u>. Please note that these estimates include the <u>anticipated time for the 3 tasks / projects noted above</u>.

#### 1) General

a) Provide periodic services as requested during construction in such a manner as to assist in securing the faithful execution and completion of the construction contract in accordance with the contract documents.

- i) 16 hours is budgeted for this task (for all 3 projects / tasks).
- 2) Preconstruction Meeting
  - a) CT will attend the preconstruction meeting with OLSD and Contractor to outline specific project requirements, solicit contractor information and facilitate timely commencement of the work.
    - i) 6 hours is budgeted for this task (3 tasks / projects 2 hours each).
- 3) Submittals
  - a) CT will review and provide comments and recommend approval for submittals throughout the construction process. The submittals include, but are not limited to, the following:
    - i) Shop Drawings: CT will receive and review all necessary shop drawing submittals. CT's review comments will be provided directly to the Contractor. CT will maintain a log of shop drawings received. An initial and second review are included in our fee. Further reviews will be considered additional services.
      - (1) 40 hours is budgeted for this task (for all 3 tasks).
    - ii) Pay Applications: CT will review and provide a recommendation to the Owner for payment of all pay applications.
      - (1) 24 hours is budgeted for this task (3 tasks 8 hours each).
    - iii) Change Orders: CT will prepare the change order requests, as needed, and all other related contract documents. CT will review Contractor's inquiries regarding site conditions, construction document clarifications, field changes, etc. and respond accordingly with recommendations to the Owner.
      - (1) 16 hours is budgeted for this task (for all 3 tasks).
    - iv) Clarifications and Interpretations: CT will receive from the Contractor any matters in question concerning the requirements of the Contract Documents (sometimes referred to as requests for information or interpretation—RFIs), or relating to the acceptability of the Work under the Contract Documents. In response, CT will provide the Contractor interpretations and decisions as necessary to clarify the intent of the Contract Documents.
      - (1) 16 hours is budgeted for this task (for all 3 tasks).
- 4) Monthly Progress Meetings
  - a) CT will conduct any monthly progress meetings with OLSD and the Contractor as requested.
    - i) 24 hours is budgeted for this task (3 tasks 8 hours each).
- 5) Project Completion

- a) CT will be available for a final inspection meeting and develop a punch list of items to be completed. Upon completion of all punchlist items by the Contractor, CT will inspect and then make a recommendation to OLSD in regards to final completion.
  - i) 24 hours is budgeted for this task (3 tasks 8 hours each).

#### 6) As-Built Drawings

- a) CT will prepare the as-built drawings in AutoCAD based on the information provided by the contractor and CT's RPR. The as-built process does not include an actual survey of the waterline prior to backfilling. This service can be provided for an additional service or by the Contractor. The Owner will be provided with a PDF set of the as-built drawings for these improvements.
  - i) 60 hours is budgeted for this task (3 tasks 20 hours each).

#### **Task 5 - Construction Observation Services**

The construction observation services for these improvements, which will be performed on a periodic basis as requested, and will include the following:

- 1) Resident Project Representative (RPR)
  - a) CT shall furnish a Resident Project Representative ("RPR"), as requested, to assist in providing <u>periodic</u> observation of the progress and quality of the construction work ("Work") by the Contractor. The RPR is CT's representative at the site and will act as directed by and under the supervision of CT's Construction Manager.
    - i) 120 hours is budgeted for this task (3 tasks 40 hours each).
  - b) Through the RPR's observations of the work, including field checks of materials and installed equipment, CT shall attempt to provide further protection for the Owner against defects and deficiencies in the Work. However, CT shall not, as a result of such RPR observations of the Work, supervise, direct, or have control over the Work, nor shall CT (including the RPR) have authority over or responsibility for the means, methods, techniques, sequences, or procedures of construction selected or used by any Contractor, for security or safety at the Site, for safety precautions and programs incident to the Work or any Contractor's work in progress, for the coordination of the Contractor's work or schedules, or for any failure of any Contractor to comply with Laws and Regulations applicable to the performing and furnishing of its work. CT (including RPR) neither guarantees the performances of any Contractor nor assumes responsibility for any Contractor's failure to furnish and perform the Work, or any portion of the Work, in accordance with the Construction Contract Documents.
  - c) The duties and responsibilities of the RPR are as follows:
    - ) General: RPR's dealings in matters pertaining to the Work in general shall be with CT's Construction Manager and the Contractor as directed. RPR's dealings with Subcontractors shall only be through or with the full knowledge and approval of Contractor. RPR shall generally communicate with Owner only with the knowledge of and under the direction of CT's Construction Manager.

- ii) Defective Work: Report to CT's Construction Manager whenever any part of the Work is defective under the standards and terms set forth in the Construction Contract Documents, and provide recommendations as to whether such Work should be corrected, removed and replaced, or accepted as provided in the Construction Contract Documents.
- iii) Non-Compatible Work: Report to CT's Construction Manager whenever any part of the Work is not defective under the terms and standards set forth in the Construction Contract Documents, but is nonetheless not compatible with the design concept of the completed Project as a functioning whole, and provide recommendations for addressing such Work.; and advise when Work should be uncovered for observation, or requires special testing, inspection, or approval.
- iv) Daily Reports: Prepare a daily report or keep a diary or log book, recording Contractor's hours on the Site, Subcontractors present at the Site, weather conditions, data relative to questions of Change Orders, Field Orders, Work Change Directives, or changed conditions, Site visitors, deliveries of equipment or materials, daily activities, decisions, observations in general, and specific observations in more detail as in the case of observing test procedures.
- v) Construction Photographs: Take general photographs of the construction progress.

#### Fee and Billing

CT proposes to provide the services for Task 1 through 3 described herein for a Lump Sum Fee of \$79,000, which includes typical "reimbursable" expenses (copies, mileage, etc.).

CT shall has estimated a budget of \$41,000 for Task 4 (Construction Administration) and Task 5 (Construction Observation Services) described herein. This budget will not be exceeded without notifying the Owner. These services and related expenses will be billed at the hourly and reimbursable rates in effect at the time the work is completed. The total estimated budget for the services described herein is \$120,000.

This offer remains valid for 30 days; acceptance thereafter is subject to our approval. From the date of acceptance of this agreement, the above fees will apply for one year. If the work is not completed during that period, the agreement may be subject to renegotiation.

Invoices will be submitted monthly based on the percentage amount of work CT estimates to have been completed during that period. Invoices are due within 30 days of receipt.

#### **Assumptions and Exclusions**

The following assumptions and exclusions are provided for the benefit of both CT and the Owner to better understanding the limitations and expectations with respect to the proposed scope of services and the obligations of each party. These items were considered while defining our proposed scope and fee.

- 1) Field survey has already been performed by CT. No additional field survey is included.
- 2) The Piatt Road widening project will follow the Delaware County Engineer development review process.
- 3) The existing roadway pavement will not be milled and resurfaced.
- 4) Lighting design is not included.
- 5) Right-of-Way plan development and acquisition is not included
- 6) Subsurface Utility Location services are not included
- 7) Geotechnical subsurface investigations are not included
- 8) Research on jurisdictional waters is not included
- 9) Environmental services and permitting are not included
- 10) As-built Surveying / GPS services are not included
- 11) Fees for Applications, Permits, Plan Reviews or any other fees to governmental agencies are not included in this proposal. It is the responsibility of the Client to pay these fees at the time of submittal if any such fee is required.

#### **Owner's Responsibilities**

- 1) Owner shall provide all information relative to the project and assist with obtaining pertinent information from others that may be relied upon.
- 2) The Owner will make every effort to make the necessary provisions for CT to enter upon public and private property as required for CT to perform services under this agreement.
